Important Instructions:

1. The shortlisted candidates of the **Main Merit List (including waiting list)** may deposit the prescribed fee of **Rs.10000/-** (Admission Fee: Rs. 8000/, Local Fund: Rs. 1500/- and Caution Money: Rs. 500/-) through online payment gateway (link is available on **Online Admission 2023** portal on the main page of the University website *i.e.* www.uok.ac.in) from the **17th November 2022 to 19th November 2022** after due verification of the documents in **Department of Commerce and Management, University of Kota, Kota**. The last date of document verification and subsequently fee deposition is **19-11-22**. The verification of documents will be done between **11:00 a.m. to 5:00 p.m.** at **Room No. NB-101, Nagarjun Bhawan, Department of Commerce and Management, University of Kota, Kota**.
2. The eligible candidates are required to verify the following original documents such as marks sheets of qualifying examinations, TC & CC, board certificate, migration certificate, bonafide certificate, caste certificate, EWS, PH, NCC, NSS, sports & games certificates, etc.

3. The shortlisted candidates of the Waiting List may also deposit the prescribed fee of Rs. 10,000/ through online payment gateway during the above-mentioned dates after due verification of the documents through online/offline mode. The admission of the waitlisted candidates will be considered if candidates from the main merit list do not deposit the prescribed fee up to the last date of fee deposition. The provisional admission of waitlisted candidates will be confirmed after the last date of fee deposition.
4. Duly signed photocopies of the filled online admission form along with all the supporting documents are required for submission in the Department.
5. The candidature of the provisionally included candidates in the main merit list will stand cancelled, if the candidates fail to deposit the prescribed fee in the given time schedule as mentioned above (Point 1).
6. All admissions are subject to the verification and submission of domicile, unclear online documents, new caste certificate, validity of course and University, validity of certificates and the other relevant documents.
